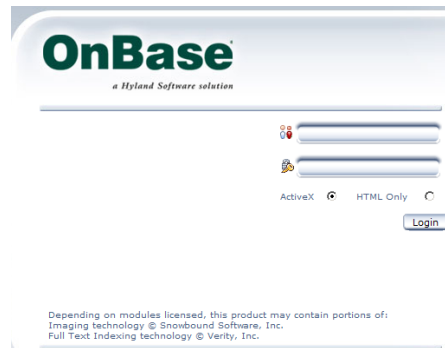

How do I find OnBase images that are not docketed yet?

Some documents are filed and scanned *before* they are docketed. Here's how to find them in OnBase when they are not yet in iCIS:

Log into OnBase at <http://coc.edm.maricopa.gov>

- Enter your user ID and password. If you have forgotten your user ID or password, contact the ECR Hotline at ECRHotline@mail.maricopa.gov.



- Select Document Type Group COSC-A
- Select your Document Type (CR, CV, FC, etc.)
- Enter your case number in the Case # field, using the "dash" between the case year and the case number. If you are looking in a Criminal case, also use a "dash" between the case number and the defendant identifier.
- Press the ENTER key to start your search.
- Look for any of the temporary docket codes below as you scroll through the search results in the top right section of your screen.
