Pre-2002 case records are being scanned and after image quality checks are completed, the paper files are no longer available. To access these imaged records, log into OnBase directly (go to http://edm.coc.maricopa.gov), and use the following instructions to retrieve the images.

Although the document type group is labeled "INACTIVE", it also contains documents for many active cases if they were initiated prior to January 2002.

Inactive Case Records Search Results

Search results for documents in the Inactive Document Type Group appear with case number and sequence number keywords in the results string. Generally speaking, the highest sequence number is equivalent to the oldest file date in the case, and the lowest sequence number is equivalent to the most recent file date.
