The annual CASE employee recognition program allows staff to nominate co-workers for special awards

The Oscars, Emmys, Tonys and Grammys are all famous awards, but in the Clerk's Office, it is those who receive a "Casey," who get all the admiration and attention of staff. Casey is the nickname of the award the Office presents to its employees through its annual CASE (Celebrating And Saluting Employees) Recognition Program.

Nominations opened on Feb. 2 for staff to submit their recommendations on who should receive a Casey this year. The award categories include: **Customer Service, Leadership, Teamwork**, and **Excellence.** The nomination process for a Casey will close on **3/3 at 3:33**.

For those who would like to submit a nomination for a co-worker and/or team of co-workers to receive a Casey, the nomination form is <u>available here</u>. Instructions are provided on the Nomination Form.

In person and virtual ceremonies will be held to award the Casey's in the coming months. Watch for further details in upcoming emails. The nominations are reviewed by a committee and the deputy directors who select the 2022 Casey recipients.

Special pins for milestone service to be presented as well



In addition to the CASE awards, service pins will be given to employees this year recognizing their milestone anniversaries with the Clerk of the Court's Office and with Maricopa County.

An announcement on who the service pin recipients are this year will be listed in the March issue of *Record Times*. This year, **80 employees** are scheduled to receive a service pin. The recipient's service ranges from 5 years to 30 years.

A remote ceremony will be held for service pin recipients for 5, 10, 15, and 20 years of service. The day and time will be announced for those ceremonies. For the fewer amount of employees with the lengthier service of 25 and 30 years service, they will be contacted about presentation of the pins.

Billing and Deferral among best in state for court collections



It was announced recently that the **Billing and Deferral** (B&D) staff are among the two best court collections agencies in Arizona. In 2021, B&D ranked second in collections just behind the Tucson City Court. The ranking honor is a part of the state's Tax Intercept Program (TIP) that collects monies owed to the court through intercepting the tax returns from non-compliant individuals. In 2021, the B&D, that operates in TIP, collected **\$1,781,996**. Ranking third in 2021 was the Superior Court in Pima County and in fourth was the Phoenix Municipal

Hearts in love and hearts to serve converge on Valentine's Day

Throughout the year, the Marriage License and Passports Office (ML) has a heart to serve the couples who come in to purchase a marriage license. However, on Valentine's Day, their hearts to serve get bigger because of the increased amount of couples who come in wanting a marriage license on



the special holiday of love. Traditionally, Valentine's Day or the Friday before Valentine's Day (if the holiday falls on a Saturday or Sunday), is the busiest day of the year for the ML staff.

This year, (even with a pandemic), the amount of couples wanting to obtain a marriage license kept the ML staff hearts beating fast as they served **145** couples, which is the second highest amount

2022 Mon. Feb. 14 145 marriage licenses for a Monday Valentine's Day. The record high for a Monday was 163 in 2011. The Office's all-time record for issuing marriage licenses on Valentine's Day is 221, which occurred on Friday, February 14, 2014. An actual Friday Valentine's Day is the busiest of the five work days with an average of 163. A Monday Valentine's Day has the second highest average of 123 MLs.

In recognition of Valentine's Day being on the 14th, the following are 14 years of the total amount of licenses ML staff issued on Valentine's Day or the Friday before when the holiday fell on a weekend.

Marriage licenses issued on Valentine's Day and the Friday nearest to Valentine's Day



Two other February days proved popular for marriage licenses Besides Valentine's Day, another time when the Marriage License (ML) staff can see a surge in people coming in to get a marriage license is on unique number sequence days, like 1-11-11. This year, the month of February had two unique number sequence days: 2-2-22 and 2-22-22. Here are the ML results of these two-rrific days: 2-2-22 = 109 MLs || 2-22-22 = 173 (28 more licenses than on Valentine's Day of this year.)

Making efforts to communicate with customers, partners, and stakeholders who work with the Office

February may be a short month, but it is a busy month for the Office. Here are two significant events the Office had/is having in February for its customers, partners, and stakeholders:



PRIVATE PROCESS SERVERS - On Feb. 16, Clerk of the Court **Jeff Fine** held a virtual meeting for the Private Process Servers and Document Runners in Maricopa County. The meeting was held to discuss several pertinent court topics related to process servers, provide related updates, allow the process servers to ask questions, and to bring in guest speakers to address other issues related to private process work

and the court. The guest speakers who came to the broadcast of the meeting held in the Downtown Justice Center included representatives from the Sheriff's Office, State Bar of Arizona, Administrative Office of Courts, and the Justice Courts. In addition to Jeff Fine, Deputy Director **Mike Nimtz** and General Counsel/ PIO **Jessica Fotinos** from the Clerk's Office also presented at the meeting.

Since 2003, the Office has monitored the certification of private process servers in Maricopa County. The Clerk's Office role and responsibilities related to the Private Process Server program include administering the Certification Exam, processing application materials, maintaining certification records, and receiving complaints made against process servers. Last fiscal year, the Office provided **42 tests** for initial applicants and renewed **223 licenses**. Process servers act an as officer of the court, but are not an employee of the court. They are legal professionals who serve legal notices and documents to the concerned party. In most cases, the server will serve summons and subpoenas to clients and defendants.



PUBLIC WEBINAR - On Feb. 24, the **Communications & Outreach Work Group** is having a public webinar titled, **"Restitution: What you Need to Know."** More than 60 people are registered for the Webinar to learn about the Clerk's Office role and responsibility in collecting and distributing fines and fees for restitution. Panelists from the Office who will present at the Webinar are Deputy Director **Mike Nimtz**, Criminal Financial Obligations Manager **Anna Castaneda**, and General Counsel/PIO **Jessica Fotinos**. The

webinar is doing a deep dive into providing information on who is eligible for restitution, the laws that govern the process, and the roles and responsibilities of the Clerk's Office Collection Unit.

Time for Open Enrollment is closing in – What to know

- This year, there will be no change to monthly employee contribution rates.
- The deduction frequency is changing from 24 to 26 pay periods.
- Enrollment will occur in Benefitssolver.
- The plan year will begin July 1 and end on December 31, 2022. There will be another mini-passive open enrollment in the fall for calendar year 2023.


