The Clerk of Court's Office held another hugely successful **Career Fair** on July 19 at the Downtown Justice Center to help fill the current job vacancies in Courtroom Services.

In an effort to bring on a number of Courtroom Clerks and to reduce the turnaround time for our hiring process, we held our second Career Fair in just two months. We received resumes from approximately **113 candidates**, scheduled **46 interviews**, welcomed **18 walk-ins**, and made **37 conditional job offers**. Due to the high number of applicants, virtual interviews are ongoing.

The Courtroom Services leadership team was amazing, running like the famous race horse "Seabiscuit" by interviewing candidates, providing detailed notes, collaborating with each other, and advising HR regarding selections. 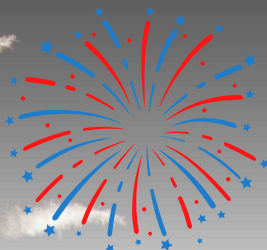
