# Who has the will in and the Office during the Summer months

The Couriers and the Microfilm staff both work at the Customer Service Center, but they experience opposite temperature working conditions in the Summer

For most Clerk staff, the working conditions during the Summer months are relatively the same as they work inside buildings that are well air-conditioned. However, there are two groups of employees who work at opposite ends of the temperature spectrum – the couriers and the staff who work in the Microfilm Storage Vault. Interestingly both of these groups work at the Customer Service Center.

During the hot summer months, the couriers are the employees who deal with the heat the most. They are outside more often than other staff when they make their daily delivery/pick-up runs. These runs require them to get in and out of the vans that have been parked in the 100+ degree temperature.

"The heat and humidity definitely wear you down by the end of the day from going in and out of cool buildings and into the hot county vans all day long," Courier **David Wolff** said. "It is important to stay hydrated because you can get very hot running around all day with the high temperatures."

On the other side of the thermometer are the CSC staff who work for periods of time in the nippy 65 degree temperature of the Microfilm Vault. The vault is kept continuously cool to preserve the film.

"During hot summer months, it feels great when working in there," Recording Services' **Rebecca Shanks** said. "It feels a little like Winter with the cool air. However, during the winter months when you work in the Vault, you might want to bring a sweater with you. The cool air is a little crisp."

Court Operations Supervisor **Tina Barrett**, who used to work in the Vault many years ago said, "It feels a little like an ice skating rink in that room and even reminds you of the Holiday season."

In the end, no matter if their working conditions are hotter or colder than other staff members, the *degree* of service for both groups are set at the same *temperature* as everyone else...*warm* service with a *cool* and calm demeanor.



# New employees are a very welcome sight



The temperatures are cooling just a bit outside of the Office, but inside the Office there is heatwave happening ... a heatwave of increased levels of new employees coming in who are bringing in much needed warm rays of sunshine to the Office. Since June, **67 new employees** have started with the Office. These employees have helped fill the over 100 vacanies the Office had as of July 1.

### Office sets new record for eFilings received in a year



**THEN:** In 2003, the Office began a pilot program allowing parties to eFile their case documents for complex civil litigation cases. Through the years, eFiling expanded to become available in Criminal (CR), Civil (CV), Family (FC), Tax (TX), and most recently in Juvenile. eFiling permits attorneys/self-represented parties to electronically file documents from their computers rather than visit the filing counters. It also enables judges, parties, and the public (where permissible) to view a case simultaneously and increases the speed and accuracy of case processing.

**NOW:** For the third consecutive year, the Office has received over a million eFilings a year. This past fiscal year set a new record as the Office received **1,229,806** efilings. Broken down by case types the eFilings were as follows: **283,920** in CV; **679,118** in CR; **160,243** in FC; **2,860** in TX, and **103,665** in Juvenile. Last year, the Office received a total of **1,116,026** eFilings.

## More than 77 million documents are in the OnBase Repository



**THEN:** In 1997, the Office began scanning the paper documents it received in Probate in order to create an electronic court record. Through the years, the scanning effort expanded to all adult case types, marriage licenses, and more recently to juvenile case types.

In addition, in 2005/2006, the Office began backscanning older cases to convert them to an electronic court record. The Office continued to backscan as needed.

These electronic court record initiatives created **one of the largest court ECR's in the nation**. The electronic images are stored in a repository called OnBase.

**NOW:** In Fiscal Year 2021/2022, **3,171,285 million documents** were added to the repository, which made for a grand total of **77,638,825 million** total documents in OnBase. **Sixty-seven** government agencies have been granted access to the electronic repository.

### **Qmatic sets new record for customers served**



**THEN:** In 2012, the Office implemented an automated customer management system at its Downtown location that streamlined serving the customers who visited the Office. Called Qmatic, among the system's benefits are it eliminated the need for customers having to stand in line and it organized the types of requested service for better efficiency

**NOW:** Qmatic is now installed at five Office locations (Downtown, and the

Offices at Northeast, Northwest, Southeast and in the Customer Service Center). This year a record **261,790** customers, who visited the Office for various court-related service needs, were served through the Qmatic system. Last year, **231,917** customers were served through Qmatic.

Week 1 - Resilience and Thriving


Week 2 - The Stress Response
