The largest government hiring event in Arizona was a smashing success! Thanks to the hard work of county leadership, staff, and HR professionals, approximately **2,295** members of the public attended Maricopa County's inaugural **Career Fair & Community Expo at Chase Field**. While wedding ceremonies were being conducted and pet adoptions were taking place, your Clerk of Court Team was there to represent!

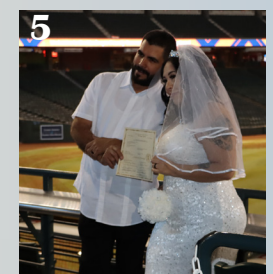
Prior to the event, we had **267 people apply** to our job postings that included Courtroom Clerks, Court Operations Specialists, Learning & Development Facilitator, and Software Developer. We had **18 interviews** scheduled and then conducted **40 more walk-up interviews**. In addition, we had approximately **150 people sign up** at the Expo to schedule an interview following the Fair. We are currently conducting follow-up interviews and scheduling additional interviews.

The team had a great time collaborating with our partners as well as had a blast hanging with the members of our staff. Major air hugs and high-fives for the COC volunteers that helped make this a HUGE success!

## The Office has a "Leap Day" every February for some staff

There is not a "Leap Day" on the February calendar this year, but that doesn't mean there isn't one in the **Marriage License and Passport Office (ML&P)** this month. In fact, there seems to be a Leap Day every year in ML&P and it occurs on Valentine's Day or the Friday before Valentine's Day, if the holiday falls on a Saturday or Sunday. The reason for the Leap Day is because the staff often busily leap to serve one couple after the other to assist them in purchasing a marriage license.

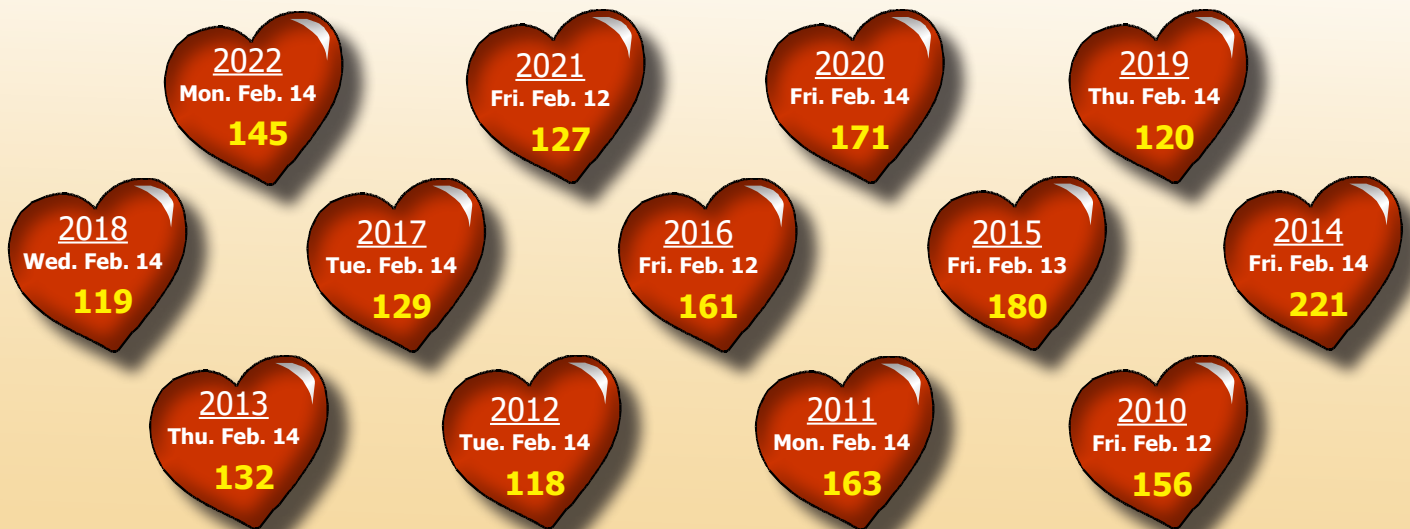
Traditionally, Valentine's Day (or the Friday before the holiday) is the busiest day of the year for ML&P staff. Through the years, the Office issues about double the amount of licenses than they do on a normal working business day. This year they issued **130 licenses**,

which is as **an all-time record when Valentine's Day is on Tuesday**. The previous high for a Tuesday Valentine's Day was 129 in 2017, and then 118 in 2012. The all-time daily record for Valentine's Day marriage license issuance was **221** in 2014, which was on a Friday.

In recognition of Valentine's Day being on the 14th, the following are 14 years of the total amount of licenses ML&P staff issued on Valentine's Day or the Friday before when the holiday fell on a weekend.

## Another February day was even more popular for marriage licenses

Besides Valentine's Day, another time when the Marriage License (ML) staff can see a surge in people coming in to get a marriage license is on unique number sequence days, like 1-11-11. Last year, the month of February had the unique number sequence days of 2-2-22 and 2-22-22. This year it had: 2-3-23. Here are the ML results of the this year's unique number sequence day as well as some previous year unique number sequence days: **2-3-23 = 136 || 2-2-22 = 109 MLs || 2-22-22 = 173 || 2-1-21 = 107**

## Office placed on U.S. Honor Roll of Passport Acceptance

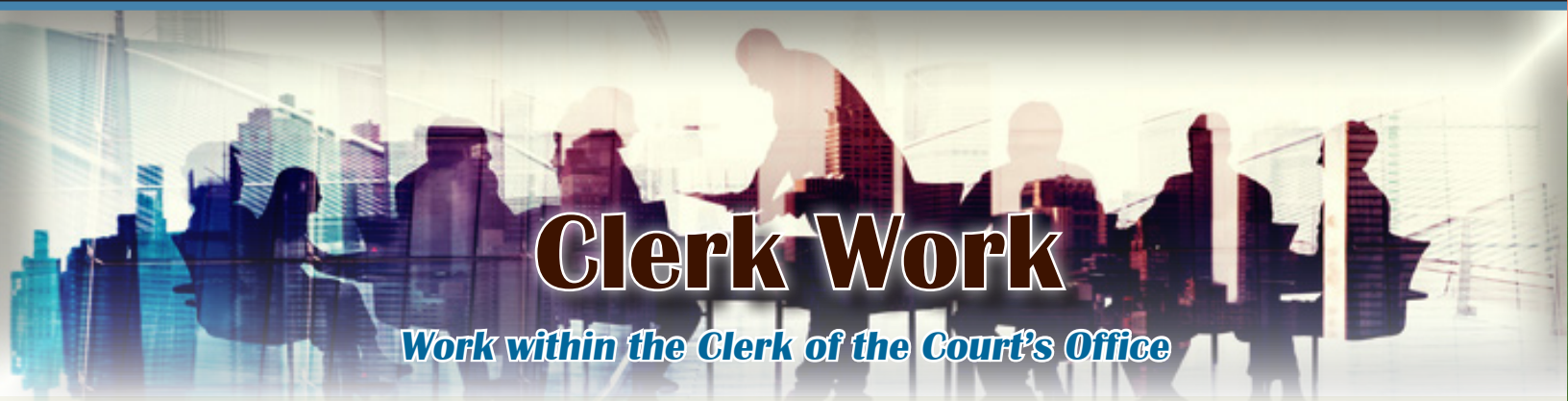


The Clerk's Office was recently recognized by the U.S. Department of State (DOS) for achieving a **100% inspection score** during the 2022 passport oversight audit, earning them a spot on the "**Acceptance Facility Honor Roll.**" This distinction was earned by only **11%** of the 90 passport acceptance facilities in the State of Arizona. This achievement demonstrates an organizational commitment to operational excellence, elevated customer service, and training standards.

The Office of Acceptance Facility Oversight (AFO), one of Passport Services' headquarters directorates, conducts independent oversight inspections that focus on protecting the integrity of the passport issuance process. AFO evaluates acceptance facility capabilities to: determine management controls for noncompliance with written guidance provided by Passport Services; mitigate the risk of fraud and mis/malfeasance; identify and report systemic trends; and assess acceptance facilities' compliance to DOS regulations.

The Clerk's Office processes over **20,000 passport applications** annually at the Downtown Customer Service Center, Northeast, Northwest, and Southeast Regional Centers.



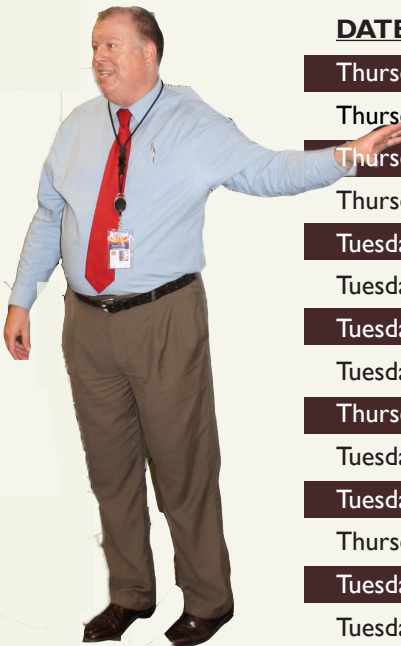

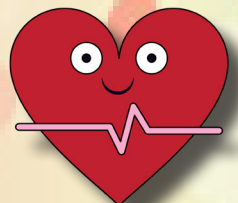
