DETENTION FACILITY TOUR PARTICIPANT’S AGREEMENT

I (print name) _____ am requesting a tour of a Maricopa County Juvenile Probation Department (MCJPD) detention facility. As a tour participant, I understand the following:

General Guidelines

- All tour participants must be over the age of 18 unless approved by the Chief Juvenile Probation Officer.
- All tour participants must show a government issued picture identification card prior to entering the facility.
- All tour participants will be subjected to a security screening prior to entering the facility.
- All bags, purses, backpacks, briefcases, food/beverages must be left in your locked vehicle or a locker at the facility.
- No profane or suggestive language is allowed.

Dress Code

- Length of skirts, dresses and shorts must be within two inches of the knee.
- All shirts, blouses and dresses must have sleeves and must cover the entire mid-section of the body so that no bare skin in the front or back is showing.
- Front and back necklines of all shirts, blouses and dresses must not be lower than the underarm.
- Shoes must be worn at all times.
- The following items are not permitted:
 1. Hats, ball caps or head coverings except those that are liturgical
 2. Clothing depicting profanity, drugs, alcohol, sex, or gangs
 3. Sheer or see through clothing

Juvenile Privacy

- Juveniles have a right to privacy while detained.
- The tour guide will make every attempt to limit contact with detained juveniles.
- If you see a juvenile you know, please do not acknowledge or speak to them or tell people you saw a juvenile you know.

Prison Rape Elimination Act (PREA)

- MCJPD strictly adheres to Public Law 108-79-SEPT. 4, 2003 117 STAT. 975 SEC. 3, Prison Rape Elimination Act (PREA). The purpose of PREA is to establish a Zero-Tolerance standard for sexual abuse and sexual harassment of juveniles who are detained in a secure facility.
- MCJPD has a strict Zero-Tolerance policy for any sexual misconduct, sexual abuse or sexual harassment with any person under the care, secure custody, or supervision of the department.
- During the tour, if you witness sexual abuse or sexual harassment of a detained juvenile immediately notify the tour guide.
- If you have knowledge of or are suspicious of sexual abuse or sexual harassment of a detained juvenile, you can notify the tour guide, complete a third party grievance or call the child abuse hotline at 1-888-767-2445.

Safety and Security

- Please follow all directions from the tour guide.
- The facility emergency response system uses the terms “All Call, Code Yellow and Code Medical.” If “All Call, Code Yellow or Code Medical” is sounded on the overhead paging system, please step against the nearest wall and remain there until directed by the tour guide.

I acknowledge I have read the above information and agree to follow all of the guidelines. I understand that my participation in the tour may be terminated at any time if I do not adhere to the above.
