eFiling is expanding in Juvenile Court

The Clerk's Office is expanding eFiling in Juvenile Court to include subsequent filings for four additional case types: Adoption Certification (AC), Adoption (JA), Dependency (JD), and Severance (JS). This is tentatively planned for early December. Future plans include the acceptance of case initiating petitions and motions for the same four case types in the first quarter of 2021. Further review is required for the Guardianship (JG) and Emancipation (JE) case types because they involve the payment of filing fees. Case types JI (Indian Relinquishment), JP (Order of Protection/Injunction Against Harassment), and JR (Relinquishment) will not be included for eFiling.



A little more in the paycheck just in time for the holidays

Employee's paychecks on December 9 may be a little higher because benefits premiums will not be deducted. The month of November has three pay periods - November 1, 15, and 29. This is why the December 9 paycheck (for the pay period that ends on November 29) will not have benefits premium deductions. This includes contributions to a health savings account and/or flexible spending account. If you have questions, you may contact the Employee Benefits Division at (602) 506-1010.

Take a scroll across the country



The National Association of Counties has a feature on its website called "County Explorer" that allows you to scroll over any county in the nation to find out specific information for that location. One of the options for information about the county includes confirmed COVID-19 cases per 10 thousand residents. This appears on the initial window when you open the site. If you desire to find out addi-

tional information about a county, then deselect (or click off) the initial window and then you will be able to scroll over each county, select a county of interest, click on it, and then you can view additional information like County Contacts, Website, County Structure, County Demographics, Economy, and Historical Population. You may view the County Explorer here.

All in a day's work - Last fiscal year, the Clerk of the Court's Office processed a daily average of \$520,384 in monies and averaged 8,132 transactions through the Cash Management system daily.

The cost of a classic Thanksgiving meal in 2020



A ccording to the American Farm Bureau Federation (AFBF), the cost of the traditional Thanksgiving feast for 10 is \$46.90, which is a \$2.01 decrease in price from last year and averages out to be less than \$5.00 per person.

"The average cost of this year's Thanksgiving dinner is the lowest since 2010," AFBF Chief Economist Dr.

John Newton said.


The AFBF survey shopping list includes turkey, bread stuffing, sweet potatoes, rolls with butter, peas, cranberries, a relish tray of carrots and celery, pumpkin pie with whipped cream, and beverages of coffee and milk, all in quantities sufficient to serve a family of 10 with leftovers.

The highest cost item was the 16-pound turkey, which came in at \$19.39 – that is roughly \$1.21 per pound and down 7% from last year. The survey showed retail turkey prices are the lowest since 2010. Items that showed the decreases this year, in addition to the turkey were: whipping cream, \$1.74 and sweet potatoes, \$3.44. Items that increased in price were: dinner rolls, \$2.66; cubed bread stuffing, \$2.81; and pumpkin pie mix, \$3.39.

More than 230 volunteers from all 50 states gathered this information looking for the best possible


prices without taking advantage of any special promotional coupons. The AFBF's Annual Thanksgiving dinner survey was first conducted in 1986.

What November could have been called

November was originally named for its position in the old Roman calendar. "Novem" means "nine" in Latin. After January and February were added to the calendar by Julius Caesar and Pope Gregory, November became the eleventh month of the year, but kept its old name. If it were changed to reflect its new position, then it could have been named **Undecimber** (from the Latin "undecim" for eleven.
