County Water Drive wants to make a big splash



For the past few years, Maricopa County has conducted a Bottled Water Drive for the homeless. Last year, a record 35,802 bottles were donated by county employees, which surpassed the previous record of 21,146 bottles. Led by the efforts of Courtroom Services Specialist Kathleen

Slabaugh, the Clerk's Northeast Office played a significant role in those numbers by donating over **5,800 bottles** over the past two years.

This year's County Water Drive is being held through **May 31.** All Clerk staff may participate. A Summer Health Tip - The importance of drinking water

With the hot summer temperatures, the need to drink more water is important as dehydration is something that can easily occur. Here are a few signs of being dehydrated: dry, sticky mouth; sleepiness or tiredness; thirst; dry skin; headache; confusion; dizziness or feeling lightheaded; decreased urine output; and for infants, no wet diapers for three hours and few and/or no tears when crying

The recommendations on how much water to drink vary depending on a person's weight, age, and activity level. An easy guide to remember is 8x8, or eight glasses of eight ounces of water each day. You can also divide your weight in pounds by two and drink that number in ounces.

Retirement planning

It is never too early to plan for your retirement! Whether you are on the road to retirement, early career, mid-career, considering it in the near future, or your very next exit is retirement, you may want to know more about the Arizona State Retirement System (ASRS). Here are some questions that may be helpful to you as you plan for your future.

Question: How much do I have to contribute to ASRS?

Answer: Your paycheck will have two deductions. One contribution for retirement and one for long-term disability. Retirement contributions are pre-tax deductions and the long-term disability contributions are after-tax.

Question: Does Maricopa County match my investment to ASRS?

Answer: Yes! Maricopa County makes an equal contribution.

Answer: ASRS contribution rates are adjusted annually to ensure the plan remains fiscally sound and able to meet current and future obligations. As a result, we will see a slight increase in the total contribution rate in the upcoming fiscal year beginning July 1. Please refer to the table to the left for the contribution percentages.

Maricopa County, here we grow again

According to figures released by the Census Bureau, Maricopa County saw the largest population increase of any county in the nation last year. More than **81,000** residents were added in 2018 making it eight straight years of gains for the county. Maricopa County's increase was the leading factor behind an over **122,700-person** increase in the State of Arizona's population, which reached **7.17 million** last year.

Maricopa County remains the fourth largest county in the United States with an estimated population of **4,410,824**. Since the last complete census in 2010, the county has increased by **593,707 people,** which is 15.6 percent growth rate.

County brings back Summer Reading Program



Maricopa County is once again offering an online Summer Reading Program called "Maricopa Reads." The program runs June through July and it is for participants of all ages. The program is designed so that participants can log their reading time online, read various stories, complete challenges, and earn digital badges. When the program begins on June 1, a secret code can be entered to unlock a special badge and bonus points will be received. Participants can also attend events at

libraries throughout the Valley to earn secret codes to receive more bonus points. Prizes that can be earned include Peter Piper Pizza and Rubio's Grill coupons. To register for the program, you may visit the <u>program site</u>. **Note**: All county employees qualify for a free library card.

County offers free fishing day at Lake Pleasant

The Maricopa County Parks Department is offering an "Arizona Free Fishing Day" at Lake Pleasant Regional Park from 7 - 10 a.m. on Saturday, June 1. The program requires no fishing license, provides fishing poles, equipment and even some bait. Participants can bring their own fishing gear if they desire to do so. There is no registration or fee to participate. The program officials encourage participants to bring folding chairs, shade, water and snacks. Summer Reminder

Keep your furry friends safe this Summer

They may be the "Dog Days of Summer," but not all of your four-legged friends want to soak up the sun. Triple-digit temperatures mean it's that time for Maricopa County Animal Care & Control (MCACC) to remind pet owners to keep a close eye on pets during the extreme heat. Did you know that some dogs can't swim? Did you realize your dogs paw pads can burn on hot pavement? Here are a few simple tips to keep in mind:

Keep pets indoors. If it is too hot for you...think

about how it must feel on our furry friends. On extremely hot days, MCACC urges pet owners to keep pets indoors. If you absolutely cannot bring your animal inside, be sure they have access to shade throughout the day. While a dog house may provide shade, it does not allow air to circulate and provides no relief from the heat. Shady trees and covered patios provide the best relief from the glaring sun. If you can, leave a mister on for your pets. A children's pool filled with ice or a low amount of water can provide them relief and something to play in.

Provide plenty of fresh, clean water. Just like us, pets can get dehydrated. Provide plenty of water in a spill proof, non-metal bowl out of direct sunlight. Be sure to change the water daily and remember that many pets won't drink if the water is too hot. Ice cubes in the bowl that will melt slowly can also provide comfort and relief when the temperatures get too high.

Limit exercise on hot days. While your dog's paw pads may be tough, they are still sensitive and can be burned when walking on hot pavement. Limit your dog's exercise on hot days and walk them during the early morning or late evening hours. If it's too hot for your bare feet, chances are it is too hot for your dog's paws! Also, if you have a pet with light-colored fur PLEASE put sunscreen on them. Dogs are susceptible to skin cancer. Many dogs lay on their back and expose their skin to those cancerous rays of sunlight. The same sun screen you wear works just as well on them.

Don't leave pets in parked cars. The temperature inside a car can soar within minutes. On an 85-degree day, the temperature inside a parked car can reach 102 degrees within 10 minutes. Keep pets at home while you run errands.

Recognize the signs of heat stress. Dogs and cats pant to regulate their body temperature, but this method can be easily overwhelmed during extreme heat. It is up to pet owners to make sure they know the signs of heat stress and how to deal with it if a situation arises. Lethargy, extreme panting, excessive

salivation, weakness and collapse are just a few of the signs of heat-related illness in pets. If your animal exhibits any of these

symptoms, apply cool (not cold) compresses and get your pet to the veterinarian immediately. Heat stress is a serious and can result in death.
