Filing for Juvenile case types will become a reality next month! The team continues to Lifine tune the new Juvenile (JV) Clerk Review and Courtroom Clerk Review modules to handle the variances with the 10 JV case types. The Judicial Review module remains the same with the exception of additional folders for the IV judges and commissioners, and additional queues in Special Queues. The first phase includes subsequent filings in delinquency (IV) cases. The primary filers are expected to be the County Attorney's Office, Office of the Public Advocate, and contract and private attorneys.

Arizona Attorney General presents award to Office

The Attorney General presented, the Clerk of the Court's Office with his "2018 Distinguished Service Award for Innovation" at a special ceremony held last month. The Attorney General recognized the office with the award for its outstanding contributions to assist victims of crime through the Victim Locate Program that the Office launched several years ago. The Victim Locate



Program was created to find the victims of crime who were not receiving their court-ordered restitution. At the end of last fiscal year, the Office had disbursed nearly **\$1.7 million** to the victims of crime.

Final Stat-urday report

The final numbers are in for the Saturday Service Days held February - April where the Office opened its doors on various Saturdays to serve the public. The Northeast Office processed **171 passports and issued 64 marriage licenses**; the Southeast Office processed **87 passports and 36 marriage licenses**; and the Customer Service Center processed **205 passports and 72 marriage licenses**.

As a result of House Bill 2564, a six percent increase in Superior Court and Justice Court filing fees took effect this month. The new fees are listed at clerkofcourt.maricopa.gov under "Filing Fees."

State budget deal includes financial relief for counties



In a *County Newsflash* posted this month, the Maricopa County Supervisors said they were very pleased to see a state budget deal that frees Arizona counties of many of the financial burdens passed onto them since the Great Recession. Since 2008, mandated cost shifts or direct contributions to the State of Arizona have cost Maricopa County more than \$300 million. The state budget deal eliminates or phases out most of those

cost shifts. During the recession, counties helped the State by absorbing losses of revenue once allocated to counties (highway, lottery funds) and paying for certain services controlled by the state (Juvenile Corrections, Department of Revenue). Yearly costs to Maricopa County were as high as \$30 million. With the new budget, mandated cost shifts or direct contributions to the State will drop to approximately \$4 million by FY 2021.

County brings back Summer Reading Program



Maricopa County is once again offering an online Summer Reading Program called "Maricopa Reads." The program runs June through July and it is for participants of all ages. The program is designed so that participants can log their reading time online, read various stories, complete challenges, and earn digital badges. When the program begins on June 1, a secret code can be entered to unlock a special badge and bonus points will be received. Participants can also attend events at libraries throughout the

Valley to earn secret codes to receive more bonus points. Prizes that can be earned include a day pass for Arizona State Parks and Trails and meals at Peter Piper Pizza and Rubio's. To register for the program, you may visit the <u>program site</u>. **Note:** All county employees qualify for a free library card.

County offers free fishing day at Lake Pleasant

The Maricopa County Parks Department is offering an "Arizona Free Fishing Day" at Lake Pleasant Regional Park from 6 - 10 a.m. on Saturday, June 2. The program requires no fishing license, provides fishing poles, equipment and even some bait. Participants can bring their own fishing gear if they desire to do so. There is no registration or fee to participate. The program officials encourage participants to bring folding chairs, shade, water and snacks. County Board of Supervisors approves tentative fiscal year 2019 Budget

The Maricopa County Board of Supervisors unanimously approved a tentative budget for fiscal year 2019 that includes "pay-for-performance" increases for employees and decreases spending year-over-year without raising the tax rate.

"Maricopa County residents want to live in safe communities with a responsive government and a low tax burden," said Board of Supervisors Chairman Steve Chucri, District 2. "This budget is all about maximizing our resources to deliver on those promises for taxpayers."



"The Board has prioritized leaner, more efficient government and the FY 2019 budget shows how those efforts are paying off," said Vice Chairman Bill Gates, District 3. "Total spending is down nearly 2% from FY 2018; we have 500 fewer

positions at the County than we did a decade ago; and we are, in many ways, providing better customer service than ever."

The \$2.45 billion budget keeps the tax rate flat from the previous year – 53.9% of the budget is allocated for public safety.

"When I joined the Board in 2013, we spent 50% of our budget on public safety. Now it's 54%," noted Supervisor Denny Barney, District 1. "As demands on our criminal justice system have grown, we've had to be more efficient. That's why we are investing in Smart Justice initiatives and new technology."

The FY 2019 budget allocates \$364 million for capital projects including \$35.5 million for a new Southeast Regional Justice Center, which will consolidate several, smaller Justice Courts along with Adult Probation services; \$4.7 million in new funding for the county parks system; \$20 million for the Recorder's Office to run this fall's primary and general elections; \$4.4 million to design the Animal Care and Control shelter expansion in Phoenix; \$1.7 million to hire additional employees; \$400,000 in additional cybersecurity funding; plus continuing money toward the construction of a new jail intake facility and the renovation of the old Madison Street Jail. In addition, the tentative budget includes nearly \$50 million increase in retirement and employee benefit costs.

"Capital spending is important to the long-term success of our community. These investments enable our staff to provide better service, and they provide great value for the taxpayer," said Supervisor Steve Gallardo, District 5.

The public will be able to comment on the tentative budget between now and the final vote, which is scheduled for June 25.
