## Unit gets top billing in 2016

Billing & Deferral Unit finishes 2016 ranked #1 in state for collection program

**A** TIP of the cap goes to a special group in the Office for finishing 2016 as number one for Debt Set Off (DSO) collections in Arizona. TIP is the Tax Intercept Program that collects monies owed to the court through intercepting the tax returns from non-compliant individuals. In 2016, the Billing and Deferral Unit that manages TIP, collected \$1,772,366, which is the second most the Office has ever collected since participating in the DSO program starting in 1996. This is the first time though the Office has finished the year with a number one ranking among the various participating Arizona courts. They have historically finished second in Arizona behind the City of Phoenix. "I congratulate our hardworking staff for this great honor and accomplishment," Deputy Director **Becky Steele** said.

## Preparing for the second new year of this year

One new year may have just started, but another type of new year will soon be here for the Office...the fiscal new year (FY) that is. The FY begins July 1 and Clerk of the Court **Michael Jeanes** and Chief Deputy **Chris Kelly** are already making preparations for it. They met with the Maricopa County Board of Supervisors on Jan. 9 to present their FY 2017 - 2018 plan for the Office. The Board is the entity that makes decisions on budget allocations for each county office/department. Michael began the presentation by highlighting the Office's recent accomplishments including the inactive case scanning

project, courtroom clerk initiative plan, and improvements to the Restitution, Fines, and Reimbursement system. He then discussed the upcoming challenges and needs of the Office.

At the end of the presentation, the supervisors were complimentary of the presentation and material he provided. The Board of Supervisors is expected to announce the budgets for county agencies in March. The Office's current FY annual budget is over \$36 million.


