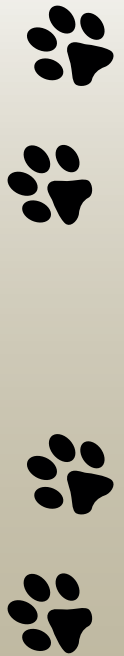

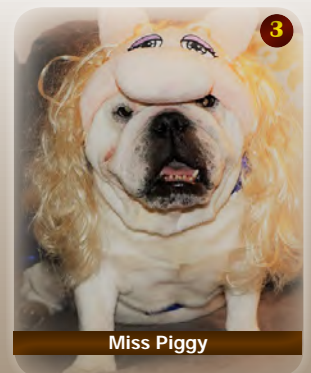

Reflecting on past generosity to the community

During the Office's Annual Holiday Drive last year, staff donated **141** pairs of socks and hundreds of personal care items to the homeless; and **146** new toys for children through the donation boxes placed in break rooms during November and December. In addition, this year Clerk of the Court employees donated **\$3,268** to Maricopa County's Combined Charitable Campaign, which assists non-profit agencies.

NOVEMBER NOTES

The cost of a classic Thanksgiving meal in 2017

According to the American Farm Bureau Federation (AFBF), the cost of the traditional Thanksgiving feast for 10 is **\$49.12**, which is a 75-cent decrease from last year's average of \$49.87.

The AFBF survey shopping list includes turkey, bread stuffing, sweet potatoes, rolls with butter, peas, cranberries, a relish tray of carrots and celery, pumpkin pie with whipped cream, and beverages of coffee and milk, all in quantities sufficient to serve a family of 10 with leftovers.



The highest cost item was the 16-pound turkey, which came in at \$22.38 – that is roughly \$1.40 per pound and a decrease of 36 cents per whole turkey from 2016. Items that showed the largest decreases this year in addition to the turkey were: a gallon of milk, \$2.99; a dozen rolls, \$2.26; two nine-inch pie shells, \$2.45; a three-pound bag of sweet potatoes, \$3.53; and a pound of green peas, \$1.53. Items that increased in price were a half-pint of whipping cream, \$2.08; a 14-ounce package of cubed bread stuffing, \$2.81; a 30-ounce can of pumpkin pie mix,

\$3.21; and a 12-ounce bag of fresh cranberries, \$2.43.

A total of 141 volunteers across 39 states gathered this information looking for the best possible prices without taking advantage of any special promotional coupons.

There was an estimated 243 million turkeys raised in the United States in 2016, which was up four percent from 2015. Minnesota was the top state in turkey production, followed by North Carolina, Arkansas, Indiana, Missouri, and Virginia.



The estimated weight of cranberries produced in the United States in 2016 was 859 million pounds. Wisconsin led all states in the production of cranberries, with 521.0 million pounds, followed by Massachusetts, New Jersey, Oregon, and Washington.



AAA estimated that 48.7 million Americans traveled 50 miles or more for Thanksgiving in 2016.



The woman who wrote “Mary Had a Little Lamb” is also responsible for Thanksgiving’s recognition as a national holiday. In 1863, writer and editor Sarah Josepha Hale convinced President Abraham Lincoln to officially declare Thanksgiving a national holiday. She wrote countless articles and letters to persuade the president.



According to a Harris Poll, most Americans like Thanksgiving leftovers more than the actual meal. Almost eight in 10 agree that the second helpings of stuffing, mashed potatoes and pie beat out the big dinner itself.
