County/City present annual Bike to Work Day April 20



Manual Bike to Work Day on Wednesday, April 20. The three-mile bicycle ride and light breakfast will be held in downtown Phoenix. Participants may choose to bicycle with a large group from Park Central Mall (3100 N. Central Ave.) to CityScape (1 E. Washington) or bicycle directly to CityScape. Participants who pre-register will receive a t-shirt and are eligible to enter a drawing for prizes. Registered participants are also invited to enjoy a light breakfast. Bicycle racks will be provided at CityScape for guests to park and lock their bikes while they enjoy their breakfast. While supplies last, free bagels will be available to all other "Bike to Work Day" guests visiting CityScape.

Maricopa County and the City of Phoenix are challenging public and private agencies to compete for the highest number of registered participants. The first, second, and third place team will receive a gold, silver, or bronze memento for their achievements. This is a "green" event so all bicyclists are encouraged to bring their own water bottles. Water for refilling bottles will be available at Park Central and CityScape, no disposable bottles will be provided. Community volunteers will be on hand to promote health, fitness, safety, bicycle commuting, clean air, and more.

National Park Week is April 16 - 24. What is your favorite National Park and why?

Laura Bedford - My favorite national park is Yellowstone. It contains numerous rivers, canyons, forests, geysers, and hot springs. There are also hundreds of animal species roaming the park such as bears, bison, elk, wolves, and antelope. It's stunning.

Jennifer Escarcega - Yellowstone National Park. I got a chance to go there years ago and loved it. Seeing "Old Faithful" go off and touring the hot springs and geysers was amazing. It is a beautiful park to visit, but don't touch the water!

Terri Pavia - Acadia National Park in Maine. It contains miles and miles of beautiful drives, hiking trails and, my favorite, a wonderful restaurant with world famous popovers.

Pam Crawford - I have two favorite national parks; one is the Grand Canyon, it's ALWAYS beautiful and every sunrise and sunset is different. I also like Yosemite National Park in California. The trees are so tall and I want to drive thru the redwood tree. Everywhere you look is just so breathtaking.

Lorraine Brown - My favorite national park is the Grand Canyon. It is beautiful and so calming to look at. Love to go there and just enjoy the beauty.

Jennifer Vigil - My favorite is Pictured Rocks National Lakeshore in Michigan's Upper Peninsula. It is a beautiful place with sandstone cliffs, beaches, sand dunes, waterfalls, lakes, forest, and Lake Superior shoreline. I grew up spending all of my summers at our cottage near the park.

Jo Harbour - It's a tie between Glacier National Park and the Grand Canyon. The awesome power water and ice have in shaping the landscape is spectacular!

Ravi Goud - Grand Canyon National Park: It is in my home state. I love the unique combinations of geological color which decorate this canyon. For an aspiring landscape photographer like me, it's a premier nature photography location on Earth.

Savanna Waters - My favorite national park is Joshua Tree National Park, CA. As children, we went camping under the stars and rock climbing. We learned how to cook over an open fire (or stove for noburn days), went rock hounding, saw lots of different animals, and just got to take a little break from normal life. The scenery there is completely beautiful, no matter what time of day it is. So if you are ever looking for a great place to camp, please consider taking a little (or not so little) drive out to old "Cali" and try out Joshua Tree National Park.

Tracee Bauer - I grew up in the Central Valley, and had my pick of three national parks: Yosemite, Kings, and Sequoia. At Yosemite - Vernal falls and the Emerald pools, lunch at the Ahwahnee Hotel, and petting the deer at the Wawona golf course. At Kings - river rafting, boating, and fishing. At Sequoia - big trees, hiking, and camping. A "valley girl" at heart!

Lesa Schaubeck - Devils Tower in Wyoming – It is the first national monument designated in 1906 and is an interactive national park. Over 400 thousand visitors climb the Tower and the over 20 American Indian Tribes have cultural affiliations including personal rituals of prayer offerings (bundles and cloths) tied to the trees around the monument. It's a spiritual place with sacred narratives that include origin legends, legends of cultural heroes, and sacred objects.

Becky DeLong - The Grand Tetons National Park is my favorite because it's so over-looked. They are right near Yellowstone and a person can drive through them, getting so close to the majestic peaks that you feel like you are in Switzerland. With more time, there are biking and hiking trails for beginners who just want a leisurely stroll or advanced athletes who want to set off on a challenging adventure. If you visit in the winter...no problem, there is skiing, snow shoeing and sledding with the best snow imaginable.

Len Keso - I have been to several national parks, but one that stands out is Olympic National Park in Washington for its diverse beauty. There is the rain forest with moss-covered trees and lush vegitation, the beautiful ocean shoreline with sandy beaches and rugged cliffs, scenic mountain lakes, the high snow-capped mountains, hiking trails, a hot springs, and wildlife.

Sheila Bullock - Yellowstone National Park: waterfalls, waterfalls, Waterfalls, Old Faithful & multitudes of other geysers, hot springs, wildlife (don't feed the bears!). Love it!
