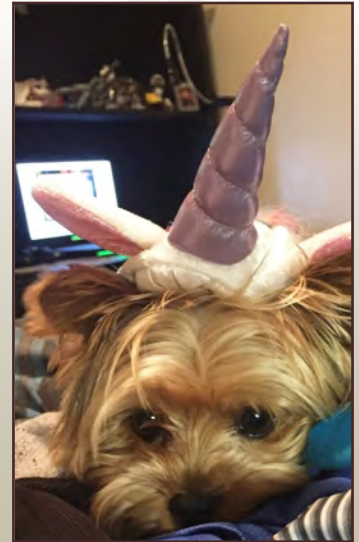

### Saturday service results

On Saturday, October 24, the Clerk of the Court's Office opened its doors from 9 a.m. to 1 p.m. at the Customer Service Center to allow the public to purchase a marriage license or apply for a passport. It was the first time the Office was open on a Saturday to provide these services. In total, 35 passport applications were processed and six marriage licenses were issued.

### Reflecting on past generosity to the community

During the Office's Annual Holiday Drive last year, staff donated 179 pairs of socks and hundreds of personal care items to the homeless; and 162 new toys for children through the donation boxes placed in break rooms during November and December. In addition, Clerk of the Court employees donated \$4,472 to Maricopa County's Combined Charitable Campaign, which assists non-profit agencies.

# NOVEMBER NOTES

## The cost of a classic Thanksgiving meal in 2015

According to the American Farm Bureau Federation, the cost of the traditional Thanksgiving feast for 10 is **\$50.11**, which is a 70 cent increase from last year's average of \$49.11.

The AFBF survey shopping list includes turkey, bread stuffing, sweet potatoes, rolls with butter, peas, cranberries, a relish tray of carrots and celery, pumpkin pie with whipped cream, and beverages of coffee and milk, all in quantities sufficient to serve a family of 10 with leftovers.

The highest cost item was the 16-pound turkey, which came in at \$23.04 – that is roughly \$1.44 per pound. Other items that showed a price increase included pumpkin pie mix, a dozen brown-n-serve rolls, cubed bread stuffing and pie shells. Items that declined modestly in price included one gallon of whole milk, butter, evaporated milk, onions, eggs, sugar, flour, a half-pint of whipping cream, 12 ounces of cranberries, a relish tray of carrots and celery, and a pound of green peas.

A total of 178 volunteers across 32 states gathered this information looking for the best possible prices.

## A side dish of Thanksgiving-related news



The first Thanksgiving was declared by Continental Congress in 1777, but the custom fell out around 1815. It wasn't until Sarah Josepha Hale, who is known for writing "Mary Had a Little Lamb," petitioned different presidents to make it a national holiday. She finally succeeded in 1863 when President Lincoln issued a proclamation.



There are four places in the US named "turkey." They are: Turkey Creek Village, LA. with 443 residents, followed by Turkey Creek, AZ. (412), Turkey City, TX (396) and Turkey Town, NC (296).



There are seven places and townships in the US that are named Cranberry, a popular side dish at Thanksgiving. Cranberry township (Butler County, PA), was the most populous of these places in 2014, with 30,170 residents.



According to the National Turkey Federation, turkey consumption has almost doubled since 1970. In 1970, U.S. consumption of turkey was 8.1 pounds person. In 2014, U.S. consumption of turkey was 15.8 pounds per person.



About 50 percent of all turkey consumed in 1970 was during the holidays. Today that percentage is around 31 percent during the holidays as more people consume turkey year-round.
