Southeast Adult Marriage License & Passport Reconfiguration

Southeast Adult ML&P was reconfigured on November 11. This reconfiguration included: additional customer seating and two additional workstations to service customers. As part of this project, a line-queuing system will be installed and implemented by January.

Southeast Juvenile Remodel Update

The Southeast Juvenile Remodel project will begin December 9. Construction will last approximately three months. In order to minimize construction time, the staff and file counters will be relocated to Southeast Adult December 7-8. When complete, the newly remodeled space will have secured file counters, standard workstations, a distribution area, and a small break room.

NOVEMBER NOTES

The cost of a classic Thanksgiving meal in 2013

According to the American Farm Bureau Federation (AFBF), the cost of the traditional Thanksgiving feast for 10 is **\$49.04**, which is a 44-cent decrease from last year's average of \$49.48.

The AFBF survey shopping list includes turkey, bread stuffing, sweet potatoes, rolls with butter, peas, cranberries, a relish tray of carrots and celery, pumpkin pie with whipped cream, and beverages of coffee and milk, all in quantities sufficient to serve a family of 10.

The highest cost item was the 16-pound turkey, which came in at \$21.76 – that is 47 cents less per whole turkey compared to 2012. Other items that declined in price included a dozen brown-n-serve rolls, \$2.18; one pound of green peas, \$1.54; a 14-ounce package of cubed bread stuffing, \$2.67; fresh cranberries, \$2.42; a half pint of whipping cream, \$1.85; and two nine-inch pie shells, \$2.49.



Items that showed a moderate price increase from last year included three pounds of sweet potatoes, \$3.36; one gallon of whole milk, \$3.66; and a 30-ounce can of pumpkin pie mix, \$3.10.

This month in history by Steve Weston

Did you know...

. . .that November 19 was the 150th anniversary of the day in 1863 when President Abraham Lincoln delivered the most famous speech in the history of the United States – **the Gettysburg Address**. Considered by not only the people of our country, but also by the British as one of the two finest political speeches ever written (the other was Lincoln's 2nd Inaugural speech), it was quite possibly the shortest political speech in history. Lincoln's address was comprised of just 272 words that made up 10 sentences; and was delivered in slightly more than two minutes; yet, despite his claim that "the world will little note, nor long remember what we say here," his words live on in the soul of our nation.

Even more interesting about that day is the fact that President Lincoln was not the featured speaker – that honor was bestowed upon the man who spoke before the President – speaking for more than two hours, yet few remember who he was and almost no one remembers what he had to say. That man, known as the finest orator of the time, was Edward Everett; who, after having listened to Lincoln's short remarks, said, "I should be glad, if I could flatter myself that I came as near to the central idea of the occasion, in two hours, as you did in two minutes."
