Maricopa County's 140th birthday celebrated this month

aricopa County celebrated its **140th birthday** on Feb. 14 at a public event at the Board of Supervisors Auditorium. On Feb. 14, 1871, the Arizona Territorial Legislature established Maricopa County by carving out a portion of Yavapai County, one of the four original Arizona counties. The creation of counties in Arizona predates Arizona becoming a state in 1912. During the next 10 years after its creation, Maricopa County's boundaries changed often, but by 1881, also the year Phoenix became incorporated, they were established as they are today. In 1889, Phoenix became the Territorial capitol. *(More about Maricopa County's history on page 6 – See 'Historical Look')*

Office has a record-breaking day on Feb. 14

Thile there isn't a Leap Day on the February calendar this year, there was still a "Leap Day" in the Clerk of the Court's Office ... and it was Monday, February 14. The reason why is because traditionally February 14, Valentine's Day (or the Friday before Valentine's Day, if the holiday falls on a Saturday or Sunday) is the busiest day of the year for the **Marriage License and Passport Office**, and so staff is *leaping* from one customer to another. On average, the Office issues between double to triple the amount of licenses during this time than it does on a normal business day. This year, the tradition carried on as the Office issued **new all-time record of 163 licenses** on Valentine's Day. This surpasses last year's record of 156 licenses that were issued. Below is a list showing the amount of licenses staff issued on Valentine's Day (or the Friday before Valentine's Day) over the past several years.

Happy 140th birthday Maricopa County!

had the honor of being one of the guest speakers at the Maricopa County 140th Birthday Celebration on Feb. 14 in the Board of Supervisors Auditorium. It was a special event with all of the county elected officials and some former elected officials taking part. It was particularly interesting to hear from the Keynote Speaker Vince Murray, a historian, who told the audience about the interesting history of how Maricopa County was created. Since this is such a historical month for the

county we live in and work for, I would like to share you with a portion of the remarks that I made at that event.

With the 140th birthday of Maricopa County being celebrated today on Valentine's Day, perhaps a more appropriate name ... for today only ... might be **Mari-Cupid** County. And perhaps Cupid's arrow did strike this area 140 years ago, because since February 1871 when the Territorial Legislature created this county, people have loved living here. The love of this area has made Maricopa County one of the fastest growing counties in the nation over the past several years. People love the weather, they love the desert scenery, they love the numerous opportunities here for recreation, education, business, industry, agriculture, technology, and entertainment, and they love the southwestern lifestyle and hospitality.

Yet, another explanation on why so many people call this great county "home" may go back again to 140 years ago when Maricopa County was created. Maricopa County was named after a tribe who called themselves "People." So, it is no wonder that a county whose name means "people" is the most populous county in Arizona and is one the most populous counties in our nation. People are what have helped make this county special. People are one of the main reasons why so many others throughout the world are attracted to this land. People are what this county is about and it is what our county government is about ... to serve its people.

In fact, in my office today, we will be serving a lot of people. As Clerk of the Court, one of the functions I oversee is the Marriage License Office and Valentine's Day is traditionally the busiest day of the year for this office. We can triple the amount of business on this day than any other day of the year from people purchasing a marriage license.

The people we are serving today in our Marriage License Office are there because of love ... Cupid has struck their hearts. And these couples have chosen Valentine's Day to celebrate their love. 

A historical look at Maricopa County


ith the 140th birthday of Maricopa County being this month, the following information from the *Maricopa County Insider – Feb. 1990* provides a look farther back into the history of the area Maricopa County now covers and how the county came into being.

During the 16th and 17th centuries, Spanish conquistadores in search of gold were the first Europeans to discover and explore the land Maricopa County now covers.

In the 18th century, Jesuit and Fransiscan priests, the most famous of whom were Padres Kino and Garces, came to this land and helped establish several of the famous Indian missions of the great Southwest.

In the 1800s, the land out West, including Maricopa County, was attractive, but since the area was under Spanish control, American exploration was discouraged. However, after 1822, the Spaniards relaxed their restrictions and allowed American traders entry into what was called the Territory of New Mexico; most of what is now Maricopa County was included in this area. In 1846, the Mexican War erupted, ending in the Treaty of Guadalupe Hildago, which ceded territory north of the Gila River to the US. Land south of the Gila River to the Rio Grande River was acquired through the Gadsen Purchase in 1853.

Maricopa County was part of Socorro and Dona Ana Counties in the New Mexico Territory until 1863, when the Arizona Territory came into being. In 1864, the Maricopa land became part of Yavapai and Pima Counties. Seven years later the county of Maricopa was created on Feb. 14, 1871.

Yolie Allen decides after 44 years, it is time to retire



n Feb. 28, Courtroom Services Manager **Yolie Allen** will retire from Maricopa County with 44 years of service – the past 24 years of that time being in the Clerk of the Court's Office. Her 44 years of service, makes her the longest-serving "Maricopa County/Clerk of Court Combined-Serving" employee in the Office. The longest "Clerk's Office Only-Serving" employee is Duffy Watson, who just reached 43 years this month. Following is an interview the *Record Times* conducted with Yolie about her retirement.

What have you enjoyed about your job? Being in Judge Gregory Martin's courtroom as his criminal courtroom clerk doing all the high profile cases. To name a few: The Buddhist Temple Murder trial in 1991, the Bob Crane (Hogan's Heroes) murder trial in 1993, and the Armored-Car murder trial in 1994 (which, in 2002, because of this case, the death sentence was overturned by the Supreme Court along with 167 other death penalty sentences in five states, ruling that juries and not judges must make the death penalty decision, which is known as the "Ring" case.)

What was your first job? Typist I at \$1.48 per hour! I was in a work experience program in high school in which students learned to fill out resumes, apply for jobs, and be allowed to work in the afternoons of our senior year. So, I was only 17 years old when I started with the County.

When you started, did you think you would be here as long as you have? No, I didn't really think about how long.

What are the biggest changes you have seen from when you started?

- Downtown went from a small-town atmosphere to a big city;
- Going from typewriters, to word processors, to computers;
- All the high rise buildings everywhere;
- Going from 18 judges to 95 judges;
- There was no Central Court Building;
- The East Court Building was called the Court building;
- The West Court Building was called the Administration building;
- All the building doors were unlocked; and
- No security anywhere.

What are some areas you have worked in?

- I started in Personnel (now Human Resources) as a Typist.
- I was then promoted as the Secretary for the County Safety Officer.
- I was promoted again as the Secretary for the Budget Director (now Office of Management and Budget).
- Next, I became the Administrative Secretary for the Purchasing Director (now Materials Management).
- I also was loaned to the Board of Supervisors and County Manager's departments to fill in as a secretary.
- I remained on-call for 2-1/2 years while I raised my son, CJ. During this period, the County started introducing smaller computers to the departments. I was brought back to Materials Management to clean all the "junk" from the bid specifications in the transfer from the large county computer to the department computer. A programmer from the Computer Department had me clicking on a program that would clean out the "junk." Well, I would have to click this program every five minutes to make it work. I didn't like that. So, I changed it to work for about 30 minutes before I had to re-enter the program. Two days later, the programmer came in to see how I was doing. I showed him what I did. He left and was very angry with me. I did not know what I did. So, I went in to see the boss and explained what happened. He started laughing. Then he tells me the reason the programmer left in a huff was because I made his program work better than he did!
- I came to the Clerk's Office as a Courtroom Clerk (while on the "Administration-side," I was always fascinated with the "Court-side" of the County.
- Finally, I am leaving as a Criminal Courtroom Services Manager.

Do you have a favorite memory or a moment that stands out in your mind about your time here?

• When we had the media camera for the first time in the courtroom of a murder trial. The microphone was placed at my desk. I thought, "Well, they will have my voice in the video, but the camera will be on the defendant. I'll have to remember not to mumble." I was very nervous. The time came to read the verdict. Afterwards, the local media news reporter came up to me and said I did a wonderful job and I articulated all the words very well. That was a relief. I then rushed home to see the news, thinking I would hear my voice, but the camera would be on the defendant. Well, the camera was on ME! I was so glad that I did NOT know the camera was on me. I probably would have fainted. After that, it got easier and easier to have the cameras in the courtroom. In fact, I then had to start remembering there were cameras and not to do something silly - like fall asleep! No, just kidding about falling asleep.

• Sticky notes behind my door (only a few people will understand this one).

Is there a particular project you accomplished that you are proud of? When I was the Secretary to the Arizona Chapter of the National Institute of Governmental Purchasing and in that capacity I revised the "NIGP Dictionary of Purchasing Terms."

What will you miss the most? The people.

What are your retirement plans?

- I will be leaving two or three days after my retirement to visit my son, daughter-in-law and granddaughter!
- I have 55 plus items on my "things to do around the house" list.
- I am planning on taking a cruise around the Hawaiian Islands in 2012 (have to wait for my cousin's husband to retire at the end of the year at the age of 51!).
- I will be taking the family to Disney World.
- I will be going to a friend's retirement in April in New Mexico.
- I will attend my aunt and uncle's 65th wedding anniversary in June in New Mexico.
- I will visit the kids at least once a month (who doesn't want to go to California during our summers?).
- I want to tour the United States.
- I will NOT have to click on any e-mails!

Any words of advice or final comments you wish to share with employees before you leave? Treat others as you would like to be treated.
