Awards bring a different type of Fall season to Office

National recognition for Office's newly implemented project

The National Association of Counties (NACo), which represents the nation's county governments in Washington D.C., provided a reason for the Clerk's Office to emphasize the "super" in the title of supervisor for Criminal Financial Obligations' **Angela Smith.** NACo recently awarded the **Victim Restitution Project** that Angela developed with a "National Achievement Award."

This project, which she developed last year, utilizes investigators from the County Attorney's Office to locate victims who are due restitution, but whom the Office has been unable to find. Before this program began, the Clerk's Office was holding more than \$3 million in pending restitution funds for victims that it was unable to disburse due to not having the correct addresses from victims who had moved or changed their names. Utilizing the County Attorney's investigative resources, additional databases, and expertise to locate these victims, the Office has released more than \$928,000 since the project began.



Road to victory - Best designed county government publication

The Office's **Annual Report**, which is titled the *Service Route* has taken the "Award Route." The National Association of County Information Officers (NACIO) selected the Office's annual report as the best designed publication among the nation's county governments in their annual "Awards of Excellence" program. The report received this "Best of Class" award in the Brochures and Publications Category. Besides this award,

the report also received an "Award of Excellence" in the overall Annual Report category. NACIO sponsors the competition each year for various county government communication projects.



Idea was \$umthing to recognize

Courtroom Clerk Caryn Smith discovered that the County's Rewarding Ideas Program really does live up to its name. She recently received a check for \$1,860 from the county rewarding her for the cost-saving idea she submitted to the program. She received the check and a certificate from Board of Supervisor's Chairman Andy Kunasek during the supervisors meeting. The following was read regarding her rewarding idea:

Caryn isolated a problem where three-part NCR forms were provided by the Adult Probation Department in opposition of stipulations agreed to in plea agreements. These forms should only have been submit-

ted to the Court when probation was either stipulated to or recommended under a no agreement plea. The recommendation was adopted and is currently utilized whenever a prison term has been stipulated to in a plea agreement. By following the stipulation in each plea agreement and eliminating the preparation of forms that are not required for sentencing, the Adult Probation Department has experienced an immediate, substantial cost savings, which resulted in a tangible savings of \$9,300.60.

Interesting items from the past in recognition of Arizona's upcoming 100th anniversary of statehood



A look at the sixth Clerk of the Court, Wilson D. "Don" Palmer

For the past several months, the *Record Times* has featured a past Clerk of the Superior Court. Last month, Robert E. Miller, the fifth Clerk of the Court was highlighted. This month W. Don Palmer, the sixth Clerk of the Court, is featured. He served in office from 1966 - 1982.

Wilson D. "Don" Palmer was born in Omaha, Nebraska on Dec. 10, 1915. During his teenage years, he had an experience that changed his life. He met Charles Lindberg, the famous aviator who was the first person to fly solo across the Atlantic Ocean. This event affected his life and instilled within him a love for aviation, which became his ambition.

He graduated from Central High School and spent as much time as he could at the Omaha City Airport. In 1933, he was appointed to be an Army aviation cadet and then became a student of the University of Maryland, under the auspices of the Army. He received a business administration degree from the University in 1934. *...continued on page 6 — See *The sixth Clerk of the Court*

Arizona History - How much do you know? (Part 7)

In recognition of Arizona's 100th statehood anniversary approaching on Feb. 14, 2012, Training and Development's **Steve Weston** is providing a series of articles related to the history of Arizona, Maricopa County, the Court, and the Clerk's Office.

id you know... that the famous shootout in Tombstone back in 1881, considered the most symbolic story of the wild, old west, known around the world as the Gunfight at the O.K. Corral, lasted a mere 30 seconds? Although he carried no badge, Wyatt Earp became the unofficial Chief of Police of Tombstone, partly because of his astute business sense, partly because of his friendship with the rather successful gambler and well-connected John "Doc" Holliday, and partly because his brother Virgil Earp was already a deputized U.S. Marshal. Together with their brother, Morgan, the Earp's and Holliday set out to rid the town of the outlaws, often provoking gunfights under the authority of Virgil's badge until one day, the outlaw bandits, the Clanton's and the McClaury's, had had enough.

Although Tombstone was the heart of the Wild, Wild West, the carrying of firearms or other deadly weapons inside the city limits was against the law. This was an attempt by the Earp's to control violence when the cowboys came to town and got drunk, and eliminate the threat that they themselves would be shot in a standoff between the interests of the business owners and the interests of the bandits.

For several days leading up to October 26, 1881, the Clanton's were in and out of jail and court for flagrantly violating



the gun ordinance. The last straw came at noon on the 26th, when Ike Clanton was spotted by several townspeople being fully armed and going from saloon to saloon, getting drunker by the minute. The Earp's arrested Ike Clanton and after a visit before the judge, Clanton paid his \$25 fine and set out to find his brother and the McClaury's. Death threats between the two sides grew louder and more credible; leading both the Clanton's and Earp's to believe a showdown was inevitable.

Finally, around 3:00 p.m on October 31, 1881, the Earp's caught up with the Clanton's and McClaury's at the OK Corral, and the shooting started. Thirty seconds later thirty shots had been fired and three men were dead. Billy Clanton and both Tom

and Frank McLaury were killed, while Morgan and Virgil Earp were wounded. Witnesses were confused as to who started shooting first, and people loyal to each side had their own ideas about what happened that day. (by Steve Weston)

He was introduced to Arizona through the Army Air Corps when his squadron, which was stationed in Salt Lake City, went to Arizona for winter maneuvers. His experience in Arizona made him realize that he wanted to make it home upon his retirement from the military.

His military career led him to be at Pearl Harbor on December 7, 1941. Immediately after the first wave of Japanese planes had attacked, his B-17 bomber was shot down but he was able to parachute out. He earned a Purple Heart medal.



Pictured above is a scanned image of a photocopied picture of the Clerk of the Court's Office on the 2nd Floor of the Old Courthouse prior to 1965.

In 1955, he retired from the military as a Chief Warrant Officer after serving for 21 years, he went back to Arizona and began working for the Bank of Douglas. In 1964, he resigned as Advertising Director of the Arizona Bank to become vice chairman of the nationwide movement to get U.S. Senator Barry Goldwater nominated as the Republican candidate for President. When he accomplished that goal, he organized "Americans for Goldwater" and was an active participant in the campaign.

In 1966, he won election as the Clerk of the Superior Court in Maricopa County. While in Office, he reduced the time it took for a lawsuit once it was filed to being entered as a permanent record from 72 days to 15 hours. It was written about him in the American Biographical Encyclopedia that he "brought the Clerk's role into the modern era and handled - with correspondingly fewer employees - a workload which increased by 118 percent. So efficient was Palmer's administration, that the Maricopa

County Clerk's Office became a Mecca for court clerks the country over. He pioneered a data retrieval system, which was copied by the U.S. Supreme Court."

Palmer was the founding president of the Arizona Association of Counties. He also served as president of the Arizona Association of Superior Court Clerks. He also was a member of the Advancement of Management.


Palmer and his wife Lucille moved to Prescott Valley in the 1990s. The couple had three children and six grandchildren. Palmer passed away in 1997.

Criminal Tower

RCC/EDC courts will open for business on February 21 with the remaining building in full operation on February 27. The move schedule is as follows:

- Criminal Exhibits 1/7 1/29
- RCC/EDC staff and Courtroom Clerks 2/17 - 2/20
- Criminal File Counters, ITG, and designated Courtroom Clerks 2/24 - 2/26

All interiors, including painting and carpet are 90% complete with the exception of furniture. Furniture installation will begin this month. The construction team is beginning to do their "punch lists." This means they are inspecting every inch of the building and making a list of all of the outstanding issues that need to be resolved. In conjunction with their "punch lists," the Clerk's Office senior management team is also completing a separate "punch list" to ensure as many issues as possible can be resolved prior to the opening of the building.
