

## A Minute with Michael

## Teamwork and looking at different angles



When Kerri Strug was a young girl, she had a big dream. She wanted to go to the Olympics and become an individual all-around champion – like Mary Lou Retton. At 13, she made the huge decision to move away from home, from Arizona to Texas, to work

with the famous gymnastics coach Bela Karoli. She worked hard and the move put her dreams within reaching distance. Eventually at the 1996 Olympics in Atlanta, Strug seemed to be approaching the possibility of living her dream of becoming an all-around individual champion. Before she could qualify for that part of the competition, however, Strug participated in the team competition as a vaulter. The team competition was an event dominated by the Russians for decades and never won by the U.S. On Strug's first vault attempt, however, the young athlete fell, injuring her ankle. Despite her very painful injury, the gold medal for her team was at hand and she still had a second vault to attempt. She was determined to help make that victory happen by giving an all out effort despite the pain to achieve something that had never been done before. She set her mind to not just finish the competition, but complete it with an even better performance knowing she was hampered. On her second attempt, she vaulted beautifully and managed to stick the landing to solidify her team winning the gold medal before she collapsed in pain.

As a consequence of her performance, she qualified for the individual all-around competition, but due to her injury she acquired during the team event she was unable to compete.

Now Strug says that while she was disappointed that she could not compete in the all-around, she realizes that by helping her team win, she had achieved something that she had not been aware was even possible when she arrived at the competition. Life, she says, has taught her that it's important to look at situations from many angles. And it's important to be open to possibilities you might not know are there.

I share this inspiring story because I think there are some similarities with our Office today. First, I see many employees making sacrifices to assist our overall team. Second, like Strug, our Office has been injured ... injured by the economic times. Third, despite our injury, many of you are giving every effort to ensure the success of our team even though it has been hard and painful. And finally, like Strug, who said she learned to look at situations from many angles and be open to new possibilities, I believe you have remained positive, determined, open to the new possibilities, and have been willing to look at different angles in order to accomplish our business goals. Thank you for your gold medal team performance!



## A few Office notes

A new option has been added in the PeopleSoft system that allows employees to **print their pay stub**. To print your pay stub, go to "**Employee Self Service**" and then in the "**Payroll and Compensation**" section click on "**View Paycheck**." When your paycheck appears on the screen, you will see at the top of the page a button that says "**Print Pay Stub**." Click on this button to print your pay stub.

The **Open Enrollment** period is May 4 - May 15. Any changes employees make to their benefit plan during Open Enrollment will be effective July 1, 2009 - June 30, 2010. Open enrollment is an opportunity to enroll in or change medical, pharmacy and dental plans, as well as change participation in the flexible savings account, Mariflex, and supplemental life insurance amounts.
