# New order to Order of Assignment process

he temperature is rising and so is a new project in the Office – the Electronic Order of Assignment (OA). The project rose to the forefront this past month and helps streamline the OA process so that the payee receives their court-ordered support sooner. The recent past process was paper-driven and required several steps by various areas to complete, which caused long delays in support payments being collected and distributed.

Through the new OA process, attorneys and parties no longer need to file a paper order of assignment with the Clerk's Office. Using the most current information provided by the parties via the filing of the Sensitive Data Sheet and at the time of the hearing, the order of assignment is created by the court-room clerk and transmitted to Family Court Services electronically for processing. Staff at Family Court Services, appointed as Special Commissioners, sign and finalize the order. OAs for consent decrees and default decrees are created by staff in Family Court Services. The OA is printed out and sent to the employers. The OA is eFiled and the image is available in OnBase.

This new electronic OA process improves the accuracy of information and expedites the delivery of orders to employers, thus improving the speed at which families receive their support. The goal is to expedite the processing time of OAs from 45 days to three days from the date of Order.

The attendant just shrugged his shoulders. "It's all a matter of perception. You will find things to be just the way you think they are."



# Some driving news - the HOV Lane

ccording to the Maricopa Association of Governments (MAG), as many as 23 percent of the total vehicles in the HOV lanes are single drivers. The HOV lanes are the lanes on the freeways restricted to carpool vehicles, motorcycles, buses, or vehicles displaying alternative fuel vehicle plates from 6 a.m. to 9 a.m. and from 3 p.m. to 7 p.m., Monday through Friday. MAG attributes the high number of violations to the fact that HOV lanes are not separated by a barrier, which makes it easy for a violator to use the HOV lane for passing to accelerate or as a temporal express lane to avoid congestion.

The mandatory fine is \$350 for driving illegally in the HOV lane. Moving in and out of the HOV lane is also dangerous to drivers in both lanes.

n June 2, the Secretary of State's Office (SSO) assumed the function of Notary Bonds processing from Superior Court Clerk Offices statewide. The change occurred as a result of legislation that was passed to streamline the application and certification process to become an Arizona Notary Public. All Notary applications and bonds are to be submitted to the SSO along with the Notary Application. The Secretary of State's Office now handles the entire process. 
## Newsletter appears on opposite sides of continent

"What the heck was that all about?" asked the snail.







The Arizona Historical Advisory Commission designated the **Old Courthouse**
