EDMS nears 10 millionth document

Since implementation in 2002, our Office's electronic repository has stored over 9,000,000 documents and over 30,000,000 pages. At the current rate of over 11,300 documents each day, the 10 millionth document will enter our repository in mid-April.

Our Office created an Electronic Document Management System (EDMS) court wide in January, 2002 after a successful pilot in Probate. One feature of our EDMS is

a document repository or digital library, which contains the images of Superior Court documents filed with the Clerk's Office. These filings include paper documents converted to an electronic form by scanning, or digital documents created by computer and electronically filed. Features of the electronic court record include minute entries distribution by email and electronic filings.

Our Office began scanning paper filings in all adult case types initiated in 2002. In 2005, we began scanning all paper filings in all adult case types, regardless of the year initially filed. We scanned and imaged an average of 11,300 documents each business day in 2005. By maintaining the court's records electronically, we will continue to expand the scope and speed of services to our diverse customers.

I give you 10 million thank you's for the tremendous work all of you have done to make EDMS a successful endeavor. I appreciate your efforts as we move forward to expand the electronic court record and reach even greater goals.

A ccording to the Census Bureau, Maricopa County will soon be the nation's 3rd largest county by population behind Los Angeles County and Chicago's Cook County. The Census reports that Maricopa is ranked number one nationally in population gains for the year ending July 1, 2005, and since the 2000 census. They report that an average of 375 people arrive in the Valley daily.


