## Courage over fire

n Sept. 30, Rose Crowley from Support Services at the Customer Service Center, parked her car in the Jackson Street garage and walked to her work area like any other day. But about 10 minutes later, her

day quickly changed when Sylvia Rosales told her that her car was on fire. She quickly ran back to the garage to find her co-worker, Fileroom's **Stephen Burkett**, spraying her car with a fire extinguisher.

Stephen said when he was walking up to the car he noticed smoke coming from it, and as he got closer he saw flames inside. He said he then quickly pulled the emergency switch in the garage to notify secu-

rity of the fire and then grabbed a nearby fire extinguisher. He began spraying the car before the fire spread to the gas tank, which could have caused a major explosion. He even had the wisdom to know not to open the car door to spray inside as the surge of oxygen from the outside air could have caused a fire blast. "I sprayed underneath the car and all around, and was ready to grab the fire house if necessary," he said.

The Fire Department quickly arrived at the scene and finished extinguishing the vehicle. Rose's car was only a year old, and according to the firemen she said that the fire appeared to be an electrical failure. She said, "Stephen is a credit to the county and all of his fellow employees. He is a hero in my eyes as his quick action helped avoid an even greater tragedy. It could have been much worse – other employees or jurors could have been harmed had it exploded and other cars could have caught on fire. Not everyone would have responded as well as he did."


